

DECLARATION OF THE PROJECT PARTICIPANT on the processing of personal data

Due to my participation in the Project "Economic Promotion of Warmia and Mazury 2020+", I declare that I acknowledge as follows:

1. The administrator of my personal data in relation to the set "Regional Operational Program for the Warmia-Masuria Province for 2014-2020" is the Warmia-Masuria Province represented by the Warmia-Masuria Province Board with its headquarters in the Marshal's Office of Warmia-Masuria Province in Olsztyn at ul. Emilii Plater 1, 10-562 Olsztyn, which is the Managing Authority of the Regional Operational Program of Warmia-Masuria Province for 2014-2020 (hereinafter referred to as Managing Authority).

2. The administrator of my personal data in relation to the set "Central teleinformation system supporting the implementation of operational programs" is the minister competent for regional development.

4. My personal data shall be processed on the basis of art. 6 § 1 letter c Regulation (EU) 2016/679 of the European Parliament and of the UE Council of April 27, 2016 on the protection of individuals due to the processing of personal data and the free movement of such data as well as waiving the Directive 95/46 / EC (General Data Protection Regulation). This implies that my personal data is necessary for the Managing Authority to fulfil legal obligations imposed on it due to the implementation of the Regional Operational Program for Warmia-Masuria Province for 2014-2020 (hereinafter referred to as : RPO WiM 2014-2020). The legal obligations associated with the Managing Authority in relation to the implementation of the ROP WiM 2014-2020 shall be determined in the following legal acts:

a) Regulation (EU) No 1301/2013 of the European Parliament and of the UE Council of December 17, 2013 on the European Regional Development Fund and specific provisions for the objective "Investments for growth and employment" and on waiving the Regulation (EC) No 1080/2006;

b) Regulation (EU) No 1303/2013 of the European Parliament and of the UE Council of December 17, 2013 establishing common rules on the European Regional Development Fund, the European Social Fund, the Cohesion Fund, the European Agricultural Fund for Rural Development as well as the European Maritime and Fisheries Fund and general provisions on the European Regional Development Fund, the European Social Fund, the Cohesion Fund, the European Maritime and Fisheries Fund and waiving Council Regulation (EC) No. 1083/2006;

c) Commission Implementing Regulation (EU) No 1011/2014 of 22 September 2014 establishing detailed rules for the implementation of Regulation (EU) No 1303/2013 of the European Parliament and of the UE Council concerning patterns for the transmission of certain information to the Commission, as well as specific provisions on exchange of information between beneficiaries and managing, certifying, auditing and intermediary bodies.

d) Act of 11 July 2014 on the rules for the implementation of programs in the field of cohesion policy financed in the financial perspective 2014-2020;

5. My personal data shall be processed only in order to execute the obligations by the Managing Authority determined by the law in connection with the implementation of the Project "Economic Promotion of Warmia and Mazury 2020+", in particular to confirm eligibility

of expenditure, support, management, monitoring, evaluation, control, audit and reporting as well as information and promotion activities under the ROP WiM 2014-2020.

8. My personal data may be entrusted or available also to specialist entities implementing assessment, control and audit surveys under the ROP WiM 2014-2020 at the request of the Managing Authority / or the Beneficiary.

9. My personal data will not be transferred to a third country or an international organisation.

10. My personal data will not be subjected to automated decision making.

11. My personal data shall be stored until full settlement of the Regional Operational Program of Warmia-Masuria Province for the years 2014-2020 and termination of archiving the documentation.

12. I shall have the right to access my personal data at any time, as well as the right to demand rectification. However, I shall be entitled to delete data, to limit data processing, to transfer the data and to raise the objection in the cases and on the terms specified in art. 17-22 RODO.

13. If I find that the processing of my personal data shall violate the provisions of the protection of personal data, I shall have the right to lodge a complaint with the supervisory body, ie the President of the Office for Personal Data Protection.

14. The provision of my data shall be voluntary, but refusal to provide it shall be equivalent to loss of possibility to participate in the realization of the Project.
